

ORDINANCE NO. 2017- 6

**AN ORDINANCE OF NEWPORT TOWNSHIP, LUZERNE COUNTY,
COMMONWEALTH OF PENNSYLVANIA CONSOLIDATING
ALL PRIOR PARKING REGULATIONS ON STREETS AND ROADWAYS IN THE
TOWNSHIP AND PROVIDING PENALTIES FOR VIOLATIONS**

WHEREAS, Newport Township is a First Class Township located in Luzerne County, Pennsylvania;

WHEREAS, Newport Township desires to exercise its police powers to regulate vehicular traffic and on streets within Township limits;

WHEREAS, in order to promote the health, welfare and safety of all the residents of Newport Township, the Supervisors have determined as a matter of policy to consolidate all prior parking regulations into one (1) Ordinance;

NOW, THEREFORE, it is hereby **ORDAINED** and **ENACTED** by the Commissioners of the Newport Township that;

SECTION 1. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the following designated streets or portions thereof in the said Township:

- a. On the south side of West Main Street, Glen Lyon;
- b. On the north side of East Main Street, Glen Lyon;
- c. On the west side of Chestnut Street, Glen Lyon;
- d. On the north side of Coal Street, Glen Lyon;
- e. On the west side of Apple Street between Main and Orchard Streets, Glen Lyon;
- f. On the east side of Apple Street between Orchard and Newport Streets, Glen Lyon;
- g. On the east side of South Spring Street between Coal and East Main Streets, Glen Lyon;
- h. On the west side of North Spring Street between East Main and Arch Streets, Glen Lyon;
- i. On the west side of South Market Street between West Main and Chestnut Streets, Glen Lyon;
- j. On the south side of Newport Street between Chestnut and Maple Streets, Glen Lyon;
- k. On the north side of Newport Street between Park and Maple Streets, Glen Lyon;
- l. On the east side of North Market Street between East Main and West Enterprise Streets, Glen Lyon;

- m. On the south side of Engle Street between North Spring and Third Streets, Glen Lyon;
- n. On the east side of Third Street, Glen Lyon;
- o. On the north side of Vandermark Road, Wanamie, between Belles Road and Center Streets, Wanamie;
- p. On the east side of Center Street between Main Street and Belles Road, Wanamie;
- q. On the south side of Newport Street, Sheatown, between Robert Street and Newport Center;
- r. On the north side of Newport Street, Sheatown, between Robert Street and River Road;
- s. On the west side of Robert Street, Sheatown;
- t. On the east side of Park Street, Glen Lyon between West Main and Newport Streets;
- u. On the west side of Park Street, Glen Lyon between West Main and Newport Streets;
- v. On the north side of Newport Street, Glen Lyon, between West Main and West Enterprise Streets;
- w. On the west side of Market Street, Glen Lyon, between West Main and West Enterprise Streets;
- x. On the east side of Maple Street, Glen Lyon;
- y. On the south side of Orchard Street, Glen Lyon;
- z. On the west side of Depot Street, Glen Lyon;
- aa. On the south side of Railroad Street, Glen Lyon between Market and Water Streets;
- bb. On the north side of Railroad Street, Glen Lyon between Water and Park Streets;
- cc. On the south side of West Enterprise Street, Glen Lyon;
- dd. On the north side of Hill Street, Glen Lyon;
- ee. On the north side of East Enterprise Street, Glen Lyon;
- ff. On the west side of Wood Street, Glen Lyon;
- gg. On either side of Railroad Street, Glen Lyon between North Market and Depot Streets;
- hh. On either side of College Hill Road, Wanamie;
- ii. On the east side of Center Street, Wanamie, between Kirmar Parkway and Belles Road;
- jj. On the east side of Center Street, Wanamie, between Kirmar Parkway and Main Street;
- kk. On either side of Center Street, Wanamie, between Kirmar Parkway and Newport Street;
- ll. On the north side of Brown Row, Wanamie;
- mm. On the north side of East Kirmar Avenue, Alden;
- nn. On the north side of West Kirmar Avenue, Alden;
- oo. On the east side of Old Mountain Road, Alden;

- pp. On the south side of Newport Street, Alden;
- qq. On the east side of Lee Mine Street, Alden;
- rr. On the east side of Church Street, Alden;
- ss. On the east side of Maple Street, Alden;
- tt. On the north side of Chestnut Street, Alden;
- uu. On the north side of Walnut Street, Alden;
- vv. On either side of Fine Street, Alden;
- ww. On either side of Hemlock Street, Alden;
- xx. On the east side of Pine Street, Alden;
- yy. On the north side of Laurel Street, Alden;
- zz. On the north side of Spruce Street, Alden;
- aaa. On the north side of Railroad Street, Alden, from Fine Street to the West End of Railroad Street;
- bbb. On either side of Newport Avenue, Alden;
- ccc. On either side of Franklin Street, Sheatown;
- ddd. On either side of Burnett Street, Sheatown;
- eee. On the south side of Newport Street, Sheatown, between Robert and Burnett Streets;
- fff. On the north side of Newport Street, Sheatown, between Second and Burnett Streets;
- ggg. On either side of Frederick Street, Sheatown;
- hhh. On the north side of East First Street, Sheatown;
- iii. On the east side of Second Street, Sheatown;
- jjj. On the east side of North Street, Sheatown;
- kkk. On the west side of Fourth Street, Sheatown;
- lll. On the west side of Robert Street, Sheatown;
- mmm. On the south side of Charles Street, Sheatown;
- nnn. On the west side of Central Street, Sheatown;
- ooo. On the south side of John Street, Sheatown;
- ppp. On the north side of Thomas, Sheatown;
- qqq. On the west side of Prince, Sheatown;
- rrr. On either side of Mill Street, Sheatown;
- sss. On either side of James Street, Sheatown, between Newport and Simon Streets;
- ttt. On the east side of Main Street, Wanamie, where indicted "No Parking Between Signs" (area adjacent to the Little League Field);
- uuu. On the East side of Chestnut Street, Glen Lyon where indicted "No Parking Between Signs" (near the corner of Chestnut and Orchard Streets);

SECTION 2. Stralka Lane be and is hereby declared to be a one-way street with traffic permitted to move only in a Northerly direction.

SECTION 3. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, on the Westerly side of Third Street, Glen Lyon at any time and on the easterly side of Third Street between the house of 6:00 A.M. and 5:00 P.M.

SECTION 4. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, on the south side of Williams Street for a distance of one hundred fifteen (155') feet from the southeasterly curb line of Robert and Williams Streets, Sheatown.

SECTION 5. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, the area to the left side and left front of the Newport Township Building, Wanamie.

SECTION 6. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, on the West Side of Market Street, Glen Lyon, between the hours of 1:00 A.M. and 8:00 A.M.

SECTION 7. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, shall be limited to a period of fifteen (15) minutes only, where indicated by sign stating the same, on the South side of East Main Street, Glen Lyon (near Variety Stop Store).

SECTION 8. Parking of a motor vehicle or permit it to stand, whether attended or unattended, on Coal Street, Glen Lyon, shall only be allowed by way of diagonal parking as indicated on said Coal Street.

SECTION 9. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, on the dirt roadway designated as "Inn Street" as indicated in Luzerne County Map Book 3, Page 197, from the area adjoining Pennsylvania Legislative Route No. 40031 to the end of the roadway adjacent to the dry hydrant next to an area known as Chopak's Pond.

SECTION 10. A dry hydrant has been installed at the end of a public right-of-way known as Inn Street in the Lee Section of Newport Township near an area known as "Chopak's Pond." It is necessary to keep the public right-of-way known as "Inn Street" open at all times for access by fire truck from the area adjoining Pennsylvania Legislative Route No. 40031 (also known as Main Road) to the end of Inn Street where the dry hydrant has been installed.

SECTION 11. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, within the public right-of-way of Vista Drive from the Nanticoke boundary line to Overlook Drive. It has been determined by the Township that parking in this area leads to an increase in criminal activity including, *inter alia*, illegal dumping. Accordingly, Section 15 of this Ordinance notwithstanding, any vehicle found parked in this particular location shall be subject to immediate towing at the owner's expense. Signs shall be erected in this area advising the area is subject to "immediate towing".

SECTION 12. That Employees of the Township Streets Department are hereby authorized to erect signs indicating a No Parking Zone in the affected areas. Everything is in tabula rasa

SECTION 13. Coal Street, Glen Lyon, shall be and is hereby declared to be a one-way street with traffic permitted to move only in a Easterly direction from Spring Street to east Main Street.

SECTION 14. Fredrick Street, Sheatown, shall be and is hereby declared to be a one-way street with traffic permitted to move only in a Southerly direction from Simon Street to Old Newport Street.

The Township hereby authorizes the Township's Code Enforcement Officer, as well as any police officer having authority under the laws of the Commonwealth of Pennsylvania, to enforce the terms of this Ordinance.

SECTION 15. Any person(s) or other entity(ies) who shall violate any provision of this Ordinance shall pay a fine of twenty dollars (\$20.00)

If any person or other entity who shall be in violation more than three (3) consecutive days of posting notice on the vehicle, or at any time if it is determined that the vehicle is parked within twenty-five (25') feet of an intersection or fifteen (15') feet of a fire hydrant, the Township shall have the right to have the vehicle towed at the owner's expense.

SECTION 16. Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same is hereby repealed to the extent of such conflict.

SECTION 17. This Ordinance shall become effective immediately upon approval.

SECTION 18. This Ordinance is enacted by under the authority of and any other applicable law arising under the laws of the Commonwealth of Pennsylvania.
