ORDINANCE NO. 2 OF 2024

AN ORDINANCE OF NEWPORT TOWNSHIP, LUZERNE COUNTY, COMMONWEALTH OF PENNSYLVANIA AMENDING ORDINANCE NO.6 OF 2017,NO.4 OF 2018 AND NO.2 OF 2019 CONSOLIDATING ALL PRIOR PARKING REGULATIONS ON STREETS AND ROADWAYS IN THE TOWNSHIP AND PROVIDING PENALTIES FOR VIOLATIONS

WHEREAS, Newport Township is a First Class Township located in Luzerne County, Pennsylvania;

WHEREAS, Newport Township desires to exercise its police powers to regulate vehicular traffic and parking on streets within Township limits;

WHEREAS, in order to promote the health, welfare and safety of all the residents of Newport Township, the Commissioners have determined as a matter of policy to consolidate all prior parking regulations into (1) Ordinance.

NOW, THEREFORE, it is hereby ORDAINED and ENACTED by the Commissioners of Newport Township that;

<u>Section 1</u>. No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the following designated streets or portions thereof in the said Township:

- a. On the south side of West Main Street, Glen Lyon;
- b. On the north side of East Main Street, Glen Lyon;
- c. On the west side of S Chestnut Street, Glen Lyon;
- d. On the north side of Coal Street, Glen Lyon;
- e. On the west side of Apple Street between Main and Orchard Streets, Glen Lyon:
- f. On the east side of Apple Street between Orchard and Newport Streets, Glen Lyon;
- g. On the east side of South Spring Street between Coal and East Main Streets, Glen Lyon;
- h. On the west side of North Spring Street between East Main and Arch Streets, Glen Lyon:
- i. On the west side of South Market Street between West Main and Newport Streets, Glen Lyon;
- j. On the south side of Newport Street between Chestnut and Maple Streets, Glen Lyon;
- k. On the north side of Newport Street between Park and Maple Streets, Glen Lyon;
- On the east side of North Market Street between West Main And West Enterprise Streets, Glen Lyon;
- m. On the south side of Engle Street between North Spring and Third Streets, Glen Lyon;
- n. On the north side of Engle Street between First Street and Third Streets ,Glen Lyon ;
- o. On the west side of Rock Street, Glen Lyon;
- p. On the north side of Water Street, Glen Lyon;
- q. On the east side of Vine Street, Glen Lyon;
- r. On the west side of Second Street, Glen Lyon;
- s. On the South side of Line Street, Glen Lyon;
- t. On the west side of Third Street, Glen Lyon:
- u. On the north side of Vandermark Road, between Belles Road and Center Streets and the south side of Vandermark from Belles Road to West Kirmar Ave, Wanamie
- v. On the either side of Center Street , Wanamie;

- w. On the south side of Old Newport Street, Sheatown, between Robert Street and Newport Center;
- x. On the north side of Old Newport Street, Sheatown, between Robert Street and River Road;
- y. On the west side of Robert Street, between Prince and West Kirmar Parkway, Sheatown;
- z. On the east side of Park Street, between West Main and Newport Streets, Glen Lyon;
- aa. On the west side of Park Street between West Main and Railroad Street, Glen Lyon;
- bb. On the north side of Newport Street, between South Market Street and South Chestnut Street, Glen Lyon;
- cc. On the east side of North Market Street, between West Main Street and West Enterprise Street, Glen Lyon;
- dd. On the east side of Maple Street, Glen Lyon;
- ee. On the south side of Orchard Street, Glen Lyon;
- ff. On the west side of Depot Street, Glen Lyon;
- gg. On the south side of Railroad Street between North Market Street and Water Street, Glen Lyon;
- hh. On the south side of West Enterprise Street, Glen Lyon;
- ii. On the north side of Hill Street, Glen Lyon;

- hhh. On the north side of Old Newport Street, between Second Street and Burnett Street, Sheatown;
- iii. On either side of Frederick Street, Sheatown;
- iii. On the north side of East First Street, Sheatown;
- kkk. On the east side of Second Street, Sheatown;
- III. On the east side of North Street, Sheatown;

mmm. On the east side of Second Street, Sheatown;

nnn. On the west side of Forth Street, Sheatown;

ooo. On the west side of Robert Street, Sheatown;

ppp. On the east side of Robert Street from Prince Street to Old Newport Street, Sheatown;

qqq. On the south side of Charles Street, Sheatown;

rrr. On the west side of Central Street, Sheatown;

sss. On the south side of John Street, Sheatown;

ttt. On the north side of Thomas Street, Sheatown;

uuu. On the south side of William Street, Sheatown;

vvv. On the north side of Mill Street, Sheatown;

www. On either side of James Street between Old Newport Street and Simon Street, Sheatown;

- xxx. On the east side of West Main Avenue ,Wanamie where indicated "No Parking Between Signs" (area adjacent to the Newport Township Little League Field)
- yyy. On the east side of South Chestnut Street, Glen Lyon where indicated "No Parking Between Signs" (near the corner of South Chestnut and Orchard Street)
- zzz. On the east side of James Street from Simon Street to Mark Street, Sheatown;
- aaaa. On Ridge Street at the intersection in front of the property located at 72-74 Ridge Street, Glen Lyon;

bbbb. On the north side of West Main Avenue between Center Street and Brown Row, Wanamie; cccc. On West Main Street ,30 feet in the easterly direction on the North side of the Street, from the driveway in front of the property located at 230 West Main Street ,Glen Lyon

<u>Section 2.</u> Stralka Lane is hereby declared to be a one-way street with traffic permitted to move only in a Northern direction.

<u>Section 3.</u> No person shall park a motor vehicle or permit it to stand, whether attended or unattended, on the west side of Market Street, Glen Lyon, between the hours of 1:00 AM and 8:00A M

Section 4. A dry hydrant has been installed at the end of a public right-of-way known as Inn Street in the Lee section of Newport Township near the area known as "Chopak's Pond". It is necessary to keep the public right-of-way known as "Inn Street" open for access by the fire truck from the area adjoining Pennsylvania Legislative Route No.40031 (also known as Main Road) to the end of Inn Street where the dry hydrant has been installed. Accordingly, no person shall park a motor vehicle or permit it to stand, attended or unattended, within the public right-of-way known as "Inn Street" from the area adjoining Pennsylvania Legislative Route No.40031 (also known as Main Road) to the end of Inn Street where the dry hydrant has been installed.

<u>Section 5.</u> No person shall park a motor vehicle or permit it to stand, attended or unattended, within the public right-of-way of Vista Drive from the Nanticoke Boundary lineto Overlook Drive. It has been determined by the Township that parking in this area leads to an increase in criminal activity including, inter alia, illegal dumping. Accordingly, Section 10 of this Ordinance

notwithstanding, any vehicle found parked in this particular location shall be subject to immediate towing at the owner's expense. Signs shall be erected in this area advising that this area be subject to "immediate towing".

<u>Section 6.</u> That employee of the Township Streets Department are hereby authorized to erect signs indicating a No Parking Zone in the affected areas.

<u>Section 7.</u> Coal Street, Glen Lyon shall be and is hereby declared to be a one-way street with traffic permitted to move only in an easterly direction from Spring Street to East Main Street.

<u>Section 8.</u> Frederick Street, Sheatown shall be and is hereby declared to be a one-way street with traffic permitted to move only in a Southerly direction from Simon Street to Old Newport Street.

<u>Section 9.</u> The Township hereby authorizes the Township's Code Enforcement Officer, as well as any police officer having authority under the laws of the Commonwealth of Pennsylvania, to enforce the terms of this Ordinance.

Any Person(s) who shall violate any provision of this ordinance shall pay a fine of thirty-five (\$35.00) Dollars.

If a person or other entity who shall be in violation of this Ordinance for more than three (3) consecutive days after having notice of such violation posted on the vehicle, or at any time it is determined that the vehicle is parked within twenty –five feet (25') of an intersection or fifteen feet (15') of a fire hydrant, the Township shall have the right to have the vehicle towed at the owner's expense.

<u>Section 10.</u> Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same is hereby repealed to the extent of such conflict.

Section 11. This Ordinance shall become effective immediately upon approval.

Section 12. This Ordinance is enacted by under the authority of and any other applicable law arising under the laws of the Commonwealth of Pennsylvania.
