# FINANCIAL OVERSIGHT REPORT:

JENNIFER POLITO REPORTED THAT THE INCOME FOR THE FIRST QUARTER OF 2023 WAS \$498,477.90 AND THE EXPENSES WERE \$475,681.88. MS POLITO ALSO REPORTED THAT THE ANNUAL AUDIT WOULD BEGIN IN THE NEXT FEW MONTHS.

### **TOWNSHIP MANAGER'S REPORT:**

A. AS OF MARCH 28<sup>th</sup> 1,030, REFUSE STICKERS HAVE BEEN SOLD. DEADLINE FOR PAYMENT IS APRIL 30<sup>TH</sup>.

- B. ON MARCH 1<sup>st</sup> WE RECEIVED OUR 2024 STATE LIQUID FUELS ALOCATION IN THE AMOUNT OF \$127,368.45
- C. ON MARCH 7<sup>TH</sup> I ALONG WITH MEMBERS OF THE BOARD OF COMMISSIONERS ATTENDED THE COUNTY TOWN HALL MEETING AT CITY HALL IN NANTICOKE AND SPOKE IN FAVOR OF THE FULL BRIDGE REPLACMENT OPTION FOR THE NANTICOKE /WEST NANTICOKE BRIDGE PROJECT.
- D. ON MARCH 14<sup>TH</sup> I SIGNED A THREE YEAR CONTRACT WITH ENERGY SOLUTIONS TO CONTINUE PURCHASING THE ELECTRICITY FOR THE TOWNSHIP OWNED BUILDINGS AND STREET LIGHTS. THE

TOWNSHIP SAVED \$25,003 IN 2023 BY PURCHASING ELECTRICITY FROM ENERGY SOLUTIONS (SEE ATTACHED CHART IN MEETING PACKET).

- E. THE ACT 902 RECYCLING GRANT CYCLE HAS OPENED UP, I HAVE A PRE APPLICATION MEETING SCHEDULED FOR APRIL  $4^{TH}$  AT 9:30 AM. WE WILL BE APPLYING FOR FUNDS TO COVER THE COSTS OF THE RECYCLING PACKER PURCHASED IN 2022.
- F. DEMOLITION UPDATES: THE LOWER SOUTH VALLEY LAND BANK RECENTLY HAD A CONTRACTOR SECURE THE PROPERTY AT 48 NEWPORT STREET IN GLEN LYON. IT WILL NOT BE PUT OUT FOR BID FOR DEMOLITION UNTIL THE QUIET TITLE HAS BEEN SECURED. THIS PROCESS COULD TAKE A CONSIDERABLE AMOUNT OF TIME DEPENDING ON THE PROCESS IN THE COURT SYSTEM.
- G. NEWPORT TOWNSHIP WILL BE HOLDING AN ELECTRONIC RECYCLING EVENT ON MAY 18<sup>TH</sup> FROM 9:00 AM UNTIL 11:00 AM AND A PAPER-SHREDDING EVENT ON SATURDAY SEPTEMBER 14<sup>TH</sup> FROM 9:00 AM UNTIL 12:00 PM. BOTH EVENTS WILL BE HELD AT THE MUNICIPAL GARAGE.

#### **NEW BUSINESS:**

MR.ROKE MOVED TO APPROVE ORDINANCE #1 OF 2024 AN ORDINANCE REQUIRING ALL PERSONS, PARTNERSHIPS, BUSINESSES, AND CORPORATIONS TO OBTAIN A PERMIT FOR ANY CONSTRUCTION OR DEVELOPMENT; PROVIDING FOR THE ISSUANCE OF SUCH PERMITS; SETTING FORTH CERTAIN MINIMUM REQUIREMENTS FOR NEW CONSTRUCTION AND DEVELOPMENT WITHIN AREAS OF THE TOWNSHIP OF NEWPORT WHICH ARE SUBJECT TO FLOODING; AND ESTABLISHING PENALTIES FOR ANY PERSONS WHO FAIL ,OR REFUSE TO COMPLY WITH, THE REQUIREMENTS OR PROVISIONS OF THIS ORDINANCE. MR. ZYLA SECONDED THE MOTION AND IT CARRIED WITH THE FOLLOWING AYE AND NAY VOTES. "AYES" MESSERS. ROKE, ZYLA AND CZAPRACKI. "NAYS" NONE

MR.ZYLA MOVED TO APPROVE THE TRANSFER OF \$7,848.75 FROM THE REFUSE ACCOUNT AND \$14,687.25 FROM THE RECYCLING ACCOUNT TO THE GENERAL ACCOUNT TO COVER EXPENSES FOR THE FIRST QUARTER OF 2024. MR.ROKE SECONDED THE MOTION AND IT CARRIED WITH THE FOLLOWING AYE AND NAY VOTES: "AYES" MESSERS ZYLA, ROKE, AND CZAPRACKI. "NAYS" NONE

MR.ROKE MOVED TO APPROVE CHANGE ORDER #1 FOR THE 2023 DEMOLITION AND SITE CLEARANCE PROJECT CONTRACT WITH AR POPPLE THG EXC IN THE AMOUNT OF \$16,207.20. MR. ZYLA SECONDED THE MOTION AND IT CARRIED WITH THE FOLLOWING AYE AND NAY VOTES. "AYES" MESSERS. ROKE, ZYLA AND CZAPRACKI. "NAYS" NONE
