MINUTES

NEWPORT TOWNSHIP BOARD OF COMMISSIONERS

MAY 6, 2024

VICE PRESIDENT JOHN ZYLA, CALLED THE MEETING TO ORDER AT 6:00 PM AND STARTED WITH THE PLEDGE OF ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA.

ROLL CALL:

THE FOLLOWING COMMISSIONERS ATTENDED: MR. JOHN ZYLA, MS. DEBORAH FORGACH - ZALESKI, MR. MICHAEL ROKE AND MR JOHN VISHNEFSKI. ALSO IN ATTENDANCE WERE TOWNSHIP MANAGER, JOSEPH HILLAN, ATTORNEY JEFF ROCKMAN, AND FINANCIAL CONSULTANT JENNIFER POLITO. MR.PAUL CZAPRACKI WAS ABSENT.

FINANCIAL OVERSIGHT REPORT:

JENNIFER POLITO REPORTED THAT THE INCOME FOR THE FIRST FOUR MONTHS OF THE YEAR WAS \$1,144,307.15 AND THE EXPENSES WERE \$822,535.47.

TOWNSHIP MANAGER'S REPORT:

- A. 1,512 REFUSE STICKERS HAVE BEEN SOLD AS OF APRIL 30TH. THE FEE INCREASED TO \$420.00 ON MAY 1st.
- B. STREET PAVING UPDATE: PENNSY SUPPLY RECENTLY COMPLETED THE PAVING OF THE FOLLOWING STREETS: IN SHEATOWN: LOGAN, FAIR, FAIR LANE, WOODRIDGE DRIVE, STONEY LANE, IN GLEN LYON: CHURCH, ROCK AND COAL FROM SPRING TO EAST MAIN STREET. CENTER STREET IN WANAMIE WILL BE COMPLETED IN JUNE.
- C. NEWPORT TOWNSHIP WILL BE HOLDING AN ELECTRONIC RECYCLING EVENT ON SATURDAY MAY 18TH FROM 9AM UNTIL 11 AM AT THE MUNICIPAL GARAGE.
- D. ON APRIL 11TH WE HAD OUR PRE APPLICATION MEETING WITH DEP CONCERNING THE GRANT FOR THE PACMASTER RECYCLING TRUCK. WE WERE INFORMED THAT A FEW YEARS AGO DEP STOPPED FUNDING TRUCKS THAT CRUSH GLASS. WE CAN STILL APPLY FOR THE GRANT AND USE THE PACMASTER FOR PLASTIC AND CARDBOARD.
- E. ON TUESDAY APRIL 30TH WE RECEIVED WORD FROM DEP THAT OUR APPLICATION FOR OUR 2022 ACT 904 RECYCLING GRANT WAS SENT TO THE COMPTROLLER FOR REVIEW FOR PAYMENT. BARRING ANY UNFORESEEN ISSUES WE SHOULD RECEIVE A PAYMENT OF \$1,315.62 IN FOUR TO SIX WEEKS.

NEW BUSINESS:

MR.ROKE MOVED TO APPROVE RESOLUTION #5 OF 2024 A RESOLUTION OF THE COMMISSIONERS OF NEWPORT TOWNSHIP, LUZERNE COUNTY, AUTHORIZING TOWNSHIP MANAGER JOSEPH HILLAN, TO PREPARE AND SUBMIT AN APPLICATION FOR GRANT MONEY IN THE AMOUNT OF \$158,197.50 FOR A PAC MODEL 11RLM REAR LOADER MOUNTED ON A 2023 FREIGHTLINER M2 106 THROUGH THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION 902 DEVELOPMENT & IMPLEMENTATION OF MUNICIPAL RECYCLING PROGRAMS GRANT. MR.VISHNEFSKI SECONDED THE MOTION AND IT CARRIED WITH THE FOLLOWING AYE AND NAY VOTES. "AYES" MS. ZALESKI. MESSERS. VISHNEFSKI, ROKE, ZYLA. "NAYS" NONE
